Junior Artist Competition

The annual South Carolina Flute Society Junior Artist Competition is open to all flutists in grades 9 and under, residing in any U.S. state. Three finalists will be selected on the basis of their recorded qualifying round to compete at the 2019 South Carolina Flute Society (SCFS) Spring Flute Festival. A staff accompanist will be provided at the contestant's expense, although contestants may bring their own accompanist if desired. A cash prize of \$100 will be awarded to the first place winner, and they will be presented in a performance at the 2020 SCFS Flute Festival. The entry fee is \$25.

Submission Qualifications

Applicant must be a current member of the SCFS. Applicants may reside in any U.S. state. Previous first-prize winners of this competition are not eligible to compete.

Materials Required for Submission

1. SCFS Competition Application Form and \$25 entry fee
2. SCFS Membership Application and membership fee, if not currently a member
3. 1 copy of recording:

Audition repertoire must be submitted on an unmarked MP3 file submitted via the dropbox link included on this form. The recording must contain **one selection of the standard repertoire** not to exceed 10 minutes. All works for flute and keyboard must be recorded using both instruments.

There must be **no identifying information of the applicant on the recording**

4. Biography of applicant (300-character limit, including spaces)

Preliminary Round Recorded Audition Repertoire

One piece of choice, not to exceed ten minutes. (All-State repertoire is permitted.)

Live Final Round Repertoire

One piece of choice, not to exceed ten minutes. (All-State repertoire is permitted.)

All materials must be postmarked by February 1, 2019 and electronic submissions must be uploaded by 11:59pm on February 1, 2019.
